2. QEEXITAANKA (DEFINITIONS)

- a) Advertising - daabacaadda, wareegaya, geliya ama daabacaadda ama keenaya in laga dhigo ama la daabacay wax war qoraal ah, oo ay ku jiraan warbaahinta elektarooniga ah, marka la eego helitaanka for sale ama kirada ee guryaha ama liiska ka mid ah guryaha leh qof kasta, ganacsi ama hay'ad oo liis gudbin guryaha laga heli karo a.

- j) Qofka - mid ka mid ah ama ka badan shaqsiyaadka, iskaashi, ururada, shirkadaha, ay wakiilada, meelaynayaay iyo wakiilada.
- k) Rent - si ay u kiraysan,-kirada sub, si aynu ama in si kale ku siiyo si loogu tixgeliyo a xaq u leedahay in mashquulin dhismaha ah ma leedahay degganaha.
- l) Nooca Galmada - qofka dhabta ah ama la aaminsan yahay khaniisnimada, heterosexuality, ama bisexuality.

4. TAABBAGELINTA GOOLASHA Fair Housing (PROMOTION OF FAIR HOUSING GOALS)

All mulkiilayaasha lahaanshaha ka badan labaatan (20) unugyada kirada gudahood ee magaalada Buffalo, iyo dhammaan xafiisyada hantida maguurtada ah gudahood ee magaalada Buffalo, iibinta in ka

badan labaatan (20) waafajin guryaha la deggan yahay sanad ah gudahood, ayaa la weyddiin doonaa in la isticmaalo loo siman yahay ee logo fursad ama war qoraal ah oo ka mid ah guryaha fursad loo siman yahay oo ku saabsan codsiyada iyo qalabka marketing, iyo in ay muujiyaan in xafiisyada kirada ama hantida maguurtada ogeysiis dadweynaha fursad loo siman yahay ee guryaha.

5. WARGELINTA LEH deggan tahay BADAN (NOTIFICATION TO MULTIPLE DWELLING OWNERS)

Milkiilaha kasta oo looga baahan yahay si ay u helaan shahaadada filanka ah sida lagu faahfaahiyey Buffalo Code §129-6 sidoo kale buuxi doona shahaado ka hor sheegay in shahaadada filanka laga yaabaa in lagu soo saartay in mulkiilaha waa ogyahay Fair Housing Qaynuunka ee magaalada Buffalo, iyo ayaa helay nuqul ka mid ah Qaynuunka yiri. The Department of Ogolaanshaha iyo Inspection Services hubin doontaa in milkiilayaasha ay helaan nuqul ka mid ah Fair Housing ku Qaynuunka.

6. Caadooyinka wax lagu faquuqo sharci darro ah (UNLAWFUL DISCRIMINATORY PRACTICES)

Waxa ay noqon doontaa sharci darro ah qof kasta ama hay'ad ku hawlan iibinta ama kirada guryaha in la sameeyo waxa soo socda:

a) Diiddo in ay iska iibiso, kiraysato, kirayso, ka dhigi maqnaan kormeerka, sale ama kirada ah, ama haddii kale in la diido ama la hakiyo ka qof ama dad guryo degaan sababtoo ah da'da, midabka, caqiidada, naafanimada, xaaladda qoyska, aqoonsiga jinsiga iyo ra'y'i dhiibashada, xaaladda guurka, heerka ciidamada, asal qaran, isir, jinsi, hanaan-jinsi, asal dakhliga ama isticmaalka eey therapy ama bisad.

b) takoori karto Qofnaba in shuruudaha, xaaladaha ama mudnaanshaha sale, kirada ama heshiiska kirada ee guryaha ama in Alaabeeynta goobaha ama adeegyada daankii la xidhiidha sababta oo ah da'da, midabka, caqiidada, naafanimada, xaaladda qoyska,

7. DHAAFITAANNADA (EXEMPTIONS)

- a) kirada ee guryaha a on jagadii ay ku jiraan waafajin guryaha aan ka badnayn saddex qoys oo madax banaan oo ku nool haddii milkiilaha deggan yahay mid ka mid ah unugyada deggan tahay, ama kirada ee guryaha on jagadii ay ku jiraan in ka badan hal guri la degan yahay taas oo hoygoodu lahayn waxaa loogu talagalay wax ka badan saddex qoys ama ku nool in ka yar madax banaan haddii milkiilaha deggan yahay mid ka mid ah unugyada deggan a,
- b) Xaddididda ee kirada qolalka in guryaha dadka isku jinsi ah;
- c) kirada ah ee qol ama qolal in guryaha loogu talagalay in sidan oo kale in dadka ay ku qasban yihiin inay qayb ka mid ah rubuc nool ay la degan kale ama dadka la wadaagaan ma ay doortaan gaar ah; iyo
- d) Xakamaynta ee sale, kirada ama heshiiska kirada ee guryaha a si gaar ah dadka 55 sano jirka ah ama ka weyn iyo haweenkooduba waxay la eego da'da iyo xaaladda qoyska oo kaliya.

8. FULINTA (ENFORCEMENT)

- a) Duqa magaalada Buffalo xil doonaan Sarkaalka Fair Housing si aad u hesho, baaraan iyo / ama tixraac cabashooyinka hoos qaybtan

hay'adda aqoon cadaalad fulinta guryaha shahaado si loo baaro loona qaban cabashooyinka guryaha cadaalad ah.

b) Qof kasta ama urur, ama aan xisbi ku qiyaantay, Sarkaalka Fair Housing ku gudbin kartaa cabasho jeeda ku xad gudub ee qaybtan ka mid ah (1) sano gudahood laga bilaabo taariikhda dhicitaanka. cabasho noocan oo kale ah waxay noqon doonaan qoraal, iyo qaab sida Sarkaalka Fair Housing loo baahan yahay.

c) Sarkaalka Housing Fair ayaa u sheegi doona xisbiga eeddeeyay soddon (30) maalmood laga bilaabo maalinta la gudbin cabashada gudahood, iyo codsan xisbiga ku eeddeeyay in ay ka jawaabaan cabashada qoraal iyo labaatan (20) maalmood gudahood ah ka dib markii boostada ogeysiiska sida .. taariikhda boostada ogaysiis ah Sarkaalka Fair Housing ee la ansixiyay doono. Sarkaalka Fair Housing doonaan, intaas ka dib, sameeyo baadhitaan dhakhso ah oo xidhiidh la leh cabashada ku filan si loo ogaado in ay jirto sabab tahay in la dhisu dhaqanka takoorka.

d) Haddii, in xukunka Sarkaalka Fair Housing ah, heshiis dhedhexaadin ah qanci karo loo xalliyo lahaa cabashada, isagu / iyadu waa inay ku jiraan in qodobada heshiiska sida u baahan in xisbiga lagu eeddeeyay in ay ka fogaadaan dhaqamada takoorka sharci darro ah, oo ka mid ah waxaa laga yaabaa in magdhow sida iyo / ama gargaarka raaca sida la dul isku raacay ay labada dhinac. heshiisyada Conciliation aan la hoos gelin doonaa heshiisyada sirta.

e) 120 maalmood ee taariikhda dacwada cabashada gudahood, Sarkaalka Fair Housing ku soo gabagabeyn doona baaritaanka iyo go'aan ka gaaraan haddii ay jirto sabab tahay si ay u taageeraan natijada anshaxa takoor by xisbiga eeddeeyay iyo u gudbiyaan dacwada sida lagu faahfaahiyey qaypta Ciqaabta , hoos.

9. GANAAXYO (PENALTIES)

Marka shahaado by Sarkaalka Fair Housing in ay jirto ayaa raadinta ah ku raaca sababta tahay in lagu dhaqan takoor, Sarkaalka Fair Housing waxaa laga yaabaa:

a) Codso Magaalada Corporation Counsel in ay gudbiso talaabo ka dhan ah xisbiga eedeyay, in maxkamad awood sharci, doonaya rogida oo ka mid ah rigoore soo socda:

1) ganaax aan ka badnayn kun iyo shan boqol oo Doolar (\$ 1,500) ee dembi kasta, iyadoo fal kasta oo takoor ah loo tixgeliyo dembi gaar ah; iyo / ama

2) noqoshada ama laalista ruqsadaada wax ama ogolaansho soo saaray magaalada Buffalo, lagama maarmaanka u ah hawlgalada hoyga guryaha (s) in su'aal, iyo gargaar kasta oo siman oo kale loo baahan yahay in ay saameyn ku ujeedooyinka qaybtan; iyo / ama
