## 4.1 CPTED Mini Grant (Unity Blueprint Summit) Opioid Settlement Amendment

Agency Members approved a request to amend the Agreement to provide an additional **Ten Thousand Dollars** (\$10,000.00) in Grant Funds to support project monitoring and reporting obligations associated with CPTED Mini-Grant Initiative. With this change the total program funding will increase from \$240,000 to \$250,000.

Agency Members also approved a request to increase previously approved CPTED Mini-Grant Initiative by Thirty Thousand Seven Hundred Seventy-Five Dollars and Fifty Cents (\$30,775.50) from the BURA Not-for-Profit award allocation to the Board of Block Clubs of Buffalo & Erie County (BOBC) to ensure all approved Block Club projects are fully funded.

Motion made by Commissioner Nosworthy to approve Item 4.1, seconded by Council President Bollman and carried unanimously.
